**7.1 Precautions for safe handling**

Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

**7.2 Conditions for safe storage, including any incompatibilities**

Store in a cool, dry, well ventilated area, removed from foodstuffs. Ensure containers are adequately labelled, protected from physical damage and sealed when not in use. Do not allow to come in contact with water, either from rain, condensation or the surface on which stored. Bagged fertilisers should be stored under cover and out of direct sunlight (which degrades woven polypropylene packs). If stored in the open, do so for short periods only, and cover with a tarpaulin. If stacking is necessary, bulk bags should be stored in a stable manner, preferably in a pyramidal style. Bulk bags should not be stacked more than two high for bags containing 1000 kg or more, or more than four high for bags containing up to 500 kg. The Pallet Capacity Rating (design weight) should not be exceeded on the bottom tier for other packs. High stacking should be avoided as pressure promotes caking. Store away from farm chemicals, e.g. insecticides, fungicides and herbicides. Mildly corrosive to aluminum, zinc, copper, brass, iron and galvanised steel.
